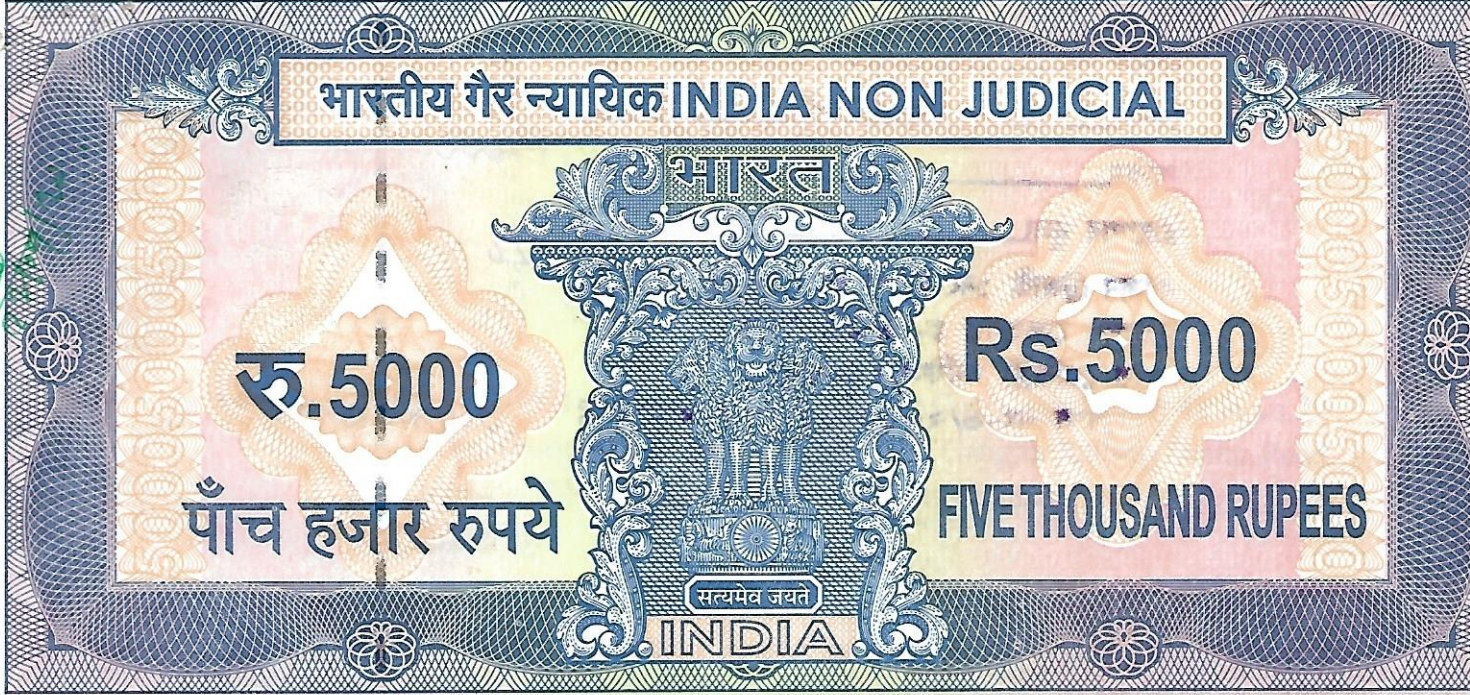

THIS INSTRUMENT OF TRUST made this the 22nd day of September 2020.

hereinafter collectively called as the "Trustees" (which terms shall unless excluded by or repugnant to the context, include the trustee or trustees for the time being of these presents and their respective successor or successors in interest and their legal representatives) of the **SECOND PART.**

WHEREAS:

- A. The Settlers have long desired to create a trust to provide for and/or impart academy, vocational, technical, and management education from nursery to higher studies and also to create facilities for health care, promotion of cultural activities to the public at large in several fields. More fully and particularly stated in the Objects Clause hereunder written.
- B. The Setters in search of the fulfilment of their above desire have agreed to carry out their above ideas and objectives through the establishment of various academicals, vocational, management and technical institutions to impart education from nursery to Higher Studies and also to create health care and other related facilities dedicated for charitable purposes.
- C. The Settlers (1) and (2) have jointly and in equal shares contributed a sum of Rs. 2,00,000/- (Rupees Two Lakhs) only and agreed to settle the said amount in trust to carry out of the objects of the trust and have further agreed to become trustees along with one other and to hold and apply the said sum of Rs. 2,00,000 (Rupees Two Lakhs only) and all gifts, contributions, subscriptions, donations, fees remuneration and other realizations for the purpose of the trust and subject to the powers and provisions contained in this presents.

D. At the request of the Settlers the Trustees (3) & (4), have agreed to act as the First Trustee along with the Settlers of these presents as testified by their being parties to and executing these presents.

NOW THIS INDENTURE WITNESSETH that with a view to give effect to the aforesaid desire and for carrying out such desire into effect the Settlers do and doth hereby grant, transfer and assign unto the Trustees ALL THAT the said sum of Rs. 2,00,000/- (Rupees two lakhs only) HAVE AND TO HOLD the same in Trust and unto and to the use of the Trustees absolutely but for the objects and purposes of the Trust mentioned hereinafter AND NOW the Settlers hereto are desirous of recording the purposes, objects, uses of the Public Charitable Trust as also the terms and conditions of the said Public Charitable Trust as follows.

NOW THIS INSTRUMENTS OF TRUST HEREBY DECLARES AND WITNESSETH AS UNDER:

1. NAME

The name of the Trust shall be **KRISHNAM FOUNDATION**.

2. OFFICE OF THE TRUST

The office of the Trust shall be situated at "**Krishnam**", Gangpur Railway Station Road, Post Office Joteram, P.S. Saktigarh, Purba Bardhaman, PIN 713104, West Bengal and/or at such other place or places as may be decided by the Trustees from time to time.

3. OBJECTS.

The main objects for which the Trust has been established are.

1. To promote, establish, incorporate, support, maintain, sponsor, impart education and run organizations, academic institutions from nursery to higher education, establishments for imparting and providing or academic, professional, vocational, and technical education in specialized and general stream including all its branch to schools, colleges, libraries, reading rooms, laboratories, research, health care, cultural activities and other institutions of the like nature in India for the benefit of the public at large.
2. To promote, establish, incorporate, support, maintain and run organizations, institutions and learning centres for academic, professional, vocational and technical education for specialised and general education from pre-primary to doctoral level, technical education from I.T.I. to post graduation and doctoral level including computer and management education, physical and health education, including institution for sports, pharmaceutical, medical, dental, homeopathic, ayurvedic, unani, nursing, naturopathy, yoga and Vedic culture, cultural institution and to carry out research and offer consultancy in the respective fields of education for the development of human resources through diffusion of useful knowledge and to grant aid and other assistances in cash or in kind to students, scholars research workers and persons showing exemplary merits in different walks of life by way of free studentships, scholarships, stipends, rewards, prizes, and allowances, etc.
3. To establish, maintain and run studentships, scholarship and render other kind of aid to students including supply of books, stipends, medals and other incentives to study without any distinction as to cast, colour, race, creed, or sex.
4. To promote, establish, support, maintain or grant aid to institutions for the promotion of all kinds of education from elementary to higher studies including science, literature, music, drama and fine arts for the preservation of historical monuments and for the research and other for institutions in India having similar objects for the benefit of the public in general.

5. To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
6. To promote, establish, support, maintain and run public libraries, study centres for the use of general public.
7. To grant certificates, diploma or degrees in the aforesaid and other allied fields.
8. To establish, maintain or grant aid for the establishment and/or maintenance of hostels and homes for the students, working classes and needy people of the society in general.
9. To give financial assistance to local authorities, municipalities and such other bodies engaged in public utility services.
10. To render assistance and / or grant to aid to recognize public charitable Trusts societies or institutions.
11. To acquire land, building, other immovable and movable assets for the above purposes.
12. And generally to do all such other things as are in incidental and conducive to the attainment of above objects.

4. OTHER OBJECTS

1. To establish and create academy and/or school and / or university in the field aforesaid.
2. To organise research and development in the fields aforesaid.
3. To establish, assign and maintain libraries, reading rooms, auditoriums and literary halls and to provide books to the deserving students.
4. To arrange debate, lectures, educational shows relation, dramatic performance, reading of papers on social philosophical, spiritual, ethical and other topics of public interest having educational value.

5. To arrange suitable accommodation for the teachers, professors, staff, students and persons attached with the aforesaid.
6. To carry out various public and/or charitable objects and purposes to all irrespective of caste community, creed.
7. For advancement of any object of general and/or public utility.

5. POWER AND FUNCTION OF THE TRUSTEES

The general management and control of the trust for the purpose of managing the trust affairs and properties shall vest in the Trustees appointed by these presents or to be appointed hereafter under provisions of these presents. For the furtherance of the objects of the trust, the trustees shall have the following powers:

1. To accept and receive donations, gifts endowments, contributions, grant or subscriptions in cash or in kind including any property from any person, body of persons, company, society or trust on such terms and conditions as the trustees may think fit and proper. Provided however that the conditions if any, attached thereto are not inconsistent with the objectives of the trust.
2. To accept, purchase, receive, take on lease or hire or otherwise acquire or transfer any movable or immovable property rights and privileges on such terms and conditions not inconsistent with the foregoing objectives of the Trust or for the benefit of the Trust.
3. To sponsor, establish, maintain and run schools, colleges, technical, vocational, and professional institutions for achieving the objectives of the Trust and manage the same by nominating members to the Governing body, Executive Committee, Academic Council and other Bodies of each sponsored institutions thus established and maintained.
4. To draw up scheme or schemes, make such arrangements and frame such laws and bye-laws and rules as the Trustees shall in their absolute discretion thinks fit and proper for the administration of the Trust hereby constituted and the management of the Trust property hereby conveyed or any part thereof or any other property for the time being subject to provisions of the this deed or

any part thereof and at any time amend, alter or repeal any of the said arrangements, schemes, laws, bye-laws or rules as they shall think fit for the development of the trust property and for furtherance of the trust objectives.

5. To apply the whole or part of the income of the Trust or accumulation thereof or whole or part of the Corpus of the Trust Fund or Trust Property for anyone or more of the objects of the Trust as the trustees may decide from time to time.
6. To borrow money from Bank, Financial Institutions, Individuals, Body Corporate, Societies, Trust or other organizations for the purpose of the trust and management of its properties against mortgage of the trust property and/or its sponsored institutions and/or personal guarantee of the trustees either individually or jointly or otherwise.
7. To invest or keep invested the Trust Fund or the income thereof either in the purchase or mortgage of immovable property or in shares, stock or debentures or other securities and investments or to keep in deposit with or loan to any company, bank, firm or any other person in conforming with the provisions of the Income Tax Act for the time being in force and to alter, vary or transpose such investments from time to time as the Trustees may in their discretion think fit and proper.
8. To convert and deal with the Trust Property and/or to vary the investments for the time being.
9. To lend money to sponsored institutions, public charitable society or trust and/or that having similar objectives fully consistent with the foregoing objectives of the Trust on such terms and conditions mutually acceptable to both.
10. To sell, alter, develop, vary, transpose, dispose of, alienate or otherwise deal with any property either movable or immovable comprising the Trust Property or any investment representing the same and to reinvest the same in any manner as the trustees may think fit as allowed Under the relevant laws.
11. To let out or demise any immovable property comprised in the Trust Property for such period and at such rent on such terms and conditions as the Trustees in their absolute discretion may think fit and proper for the benefit of the Trust.

12. To open account with any bank or banks in the name of the Trust, to operate such account and to give instructions to the bank that such account may be operated upon by one or more of the Trustees or by one or more agents appointed by the Trustees.
13. To appoint constituted Attorneys or Agents and to delegate to such Attorneys or Agents all or any of the powers vested in them under these present from time to time and to remove such Attorneys or Agents and to appoint other or others in his or other place.
14. To appoint or make provisions for appointment of any person including all or any of the Trustees as members of a Committee or as Administrator or Managing Trustees or otherwise for the purpose of administration of the Trust in such manner and subject to such rules and regulation as the trustees may prescribe and also the appoint or provide for such appointment of separate trustees to hold any property or any fund or investment subject to such rules and regulation as the trustees may from time to time think fit.
15. To make, vary, alter or modify schemes, rules and regulations for carrying out the objectives of the Trust and for the management of affairs thereof, and/or running any institution, working division, enterprise or undertaking in furtherance of the objects of the Trust and otherwise for giving effect to objects of the Trust.
16. To seek collaboration, co-operation, affiliation, accreditation and articulations with any other organizations, institutions, academies, boards, councils and universities at the national and international level for the furtherance of the objects of Trust.
17. To set the whole or part of the income or Corpus of the Trust Fund for any of the objects of the Trust and to accumulate the income for the Trust and apply the accumulated income for one or more of the objects as per provisions in the Income Tax Act, 1961.
18. To pay all charges, impositions and other outgoings payable in respect of the Trust Fund or any property comprised in the Trust and also to pay all costs and incidental to the administration and management of the Trust Fund for the time being.

19. To appoint officers or other employees or any member among themselves to look after administration and manage the properties constituting the Trust Fund/Trust Property and to allot to such persons such duties as the trustees may think fit and proper and to dismiss such officers or employees as they are found unsuitable or untrustworthy at the later date.
20. To adjust, settle, compromise, compound and refer to arbitration all actions, suits, claims demands and proceedings regarding the properties.
21. To get this Trust registered under provisions of the Income Tax Act, 1961 and to invest and set apart the surplus of income over expenditure in such manner as prescribed under the Income Tax Act, 1961 and to give donations and/or contributions to other trusts, societies and institutions whose income is exempted under provisions of the Income Tax Act, 1961.
22. To join, cooperate and amalgamate this Trust with other Trust, Societies or Fund having kindred or allied objects upon such terms and conditions as the Trustees may at their discretion think fit.
23. To do all such acts and lawful things either alone or in conjunction with other Agencies, organizations or persons as the Trustees may consider necessary, incidental or conducive to the attainment of objectives of this Trust or any of them.

6. TRUSTEES

The Trustee appointed under this presents will be for as long as they wish and will exercise powers in the name of the Trust thus created by this presents. The term of appointment, reappointment and retirement of additional Trustees shall be governed by the following provision:

1. There shall be a Board of Trustees comprising of not less than 2 (two) and not more than 7 (seven) members.
2. Any vacancy in the Board of Trustees shall be filled up by nomination of the remaining Trustees.

3. If the number of the trustees shall fall below two, the Trustees shall not except for the purpose of filling any vacancy act so long as the number is below the said minimum.
4. The Board of Trustees will be at liberty to appoint additional trustee or trustees within the number mentioned above for such period and on such terms as to retirement and re-appointment as the Board of Trustees for the time being considered proper.
5. Any trustee may resign by giving 30 (thirty) days' notice in writing to his co-trustees.
6. The Trustees may appoint anyone amongst themselves to act as the Managing Trustee with such powers and authorities as the Trustees may agree.
7. The Managing Trustee shall, unless otherwise agree, be entitled to carry out and discharge all functions of the Trust and look after all day to day matters relating to the Trust. The Managing Trustee shall however not be entitled to sale, transfer or otherwise deal with the Trust Properties by himself, unless he is specifically empowered by all the Trustees in this regard.
8. A person shall cease to be Trustee in any of the following events:
 - i) If he without leave of absence does not attend four consecutive meetings of the Board of Trustees or for one calendar year whichever may be longer.
 - ii) If he resigns, or
 - iii) If he is called upon to resign by the majority of the Trustees in writing individually or all the Trustees jointly.
 - iv) If he has become insane or mentally incapable to act as a trustee.
 - v) If he dies.
2. If a Trustee resigns, dies, retires, becomes unfit or incapable to act, the continuing or surviving trustees will be competent to appoint a trustee in place of the Trustee resigning, dying, retiring or becoming unfit or incapable to act as Trustee.

3. A Trustee and/or the Managing Trustee may delegate in writing all or any of his powers to his nominee who will be entitled so long as such nominations remains in force to exercise such power/powers in the same manner as the Trustee himself could do personally.
4. Upon the appointment of a new Trustee, the Trust Property shall vest in the new Trustee with the continuing Trustees with the powers and subject to the Trust hereby constituted.
5. The Trustees shall be chargeable only for such moneys, stocks, shares and funds as shall actually come into their hands and they shall not be answerable or accountable for neglect, default, acts or omission or commission of the other Trustees nor of any banker or other person with Whom the Trust Properties or any property may have been deposited or kept, unless caused by their wilful neglect or default.
6. The Trustee may reimburse themselves all expenses actually incurred by them in connection with the Trust or their duties relating thereto.

7. MEETING OF THE BOARD OF TRUSTEES

1. There shall be at least four meetings of the Trust in a year.
2. All meeting of the Trust shall be held at the office of the Trust unless otherwise agreed by the Trustees.
3. Notice of such meeting shall be given fifteen days in advance from the date of the meeting by the affixing notice of the meeting on the notice board of the office of the Trust.
4. Two Trustees present shall form a quorum.
5. All matters arising out at a meeting of the Trustees shall be decided by a majority of votes and in case of equality of votes, the Chairman of such meeting shall have a second or casting vote.

6. A resolution in writing circulated amongst all the Trustees and passed by a majority of the Trustees for the time being, shall be valid and effectual as if it had been passed at a meeting of the Trustees duly called and convened.

- a) The minutes of the proceedings of every meeting of the Trustees shall be entered in a book to be kept for the purpose and signed by the Chairman of such meeting or of the following meeting.
- b) The Trustees will have the absolute right, power and authority to modify the Trust Deed and/or provisions, rules or regulations.
- c) Any amendment, modification, variation as be deemed expedient and is not inconsistent with the nature and objects of the Trust may be made prospectively (and not retrospectively) by the trustees.

8. ACCOUNTS AND AUDIT.

- a) The Trustees shall keep or cause to be kept true and proper account of all moneys received and disbursed or spent for the objects and purposes of the Trust. The accounting year of the Trust shall be such as being decided by the Trustees from time to time but in accordance with the prevailing laws.
- b) The Trustees will appoint a Chartered Accountant as the Auditor of the Trust who shall certify the annual accounts of the Trust and give his report of the affairs of the Trust every year.

9. BANK ACCOUNT

The Trustees may from time to time open and maintain in the name of the Trust or in the name of its working divisions, institutions, enterprises or undertakings banking accounts or accounts and may operate the same either by themselves individually or otherwise or through their authorised agents or may decide the manner of operation of accounts from time to time by resolution in the meeting of the Board of Trustees.

10. RULES AND REGULATIONS

- a) The Trustees may from time to time make such rules and regulations for the management of affairs of the Trust not inconsistent with the main objects of the Trust as they may think fit and may from time to time alter and/or vary the same.

- b) It is expressly declared that no part of the Trust Property or its income shall be applied for any purpose which is not a Public charitable purpose in law and all provision thereof shall be consistently applied under the prevailing law of the land.

11. IRREVOCABILITY OF THE TRUST

It is hereby declared that the Trust is irrevocable if the Trust fails for any reason, in the option of the Settlers or Trustees the net assets of the Trust both movable and immovable, shall be handed over to any of the Trust having the same objects and which must have been recognized by the Income Tax authorities as required under section 11 and 12 of the Income Tax Act, 1961 and to which provisions of Section 80G would apply as per declaration by the majority of Trustees.
